ITEM 1: APPROVAL OF THE AGENDA

Document: A 81-03/501.2008 (Secretariat)

Informal document: INF.1 (Secretariat)

1. The meeting adopted the provisional agenda contained in invitation A 81-03/501.2008 dated 11 March 2008 with the list of documents published by the Secretariat in informal document INF.1.

ITEM 2: ELECTION OF BUREAU

2. Mr Helmut Rein (Germany) was re-elected Chairman. Mrs Caroline Bailleux (Belgium) was re-elected Vice-Chairman.

ITEM 3: PRESENCE AND QUORUM

3. As 15 of the 39 Member States entitled to vote were represented (see Annex 2), there was a quorum in accordance with Article 20 § 1 of the Rules of Procedure (1/3 of the Member States) and the RID Committee of Experts was able to proceed with its business.

ITEM 4: APPROVAL OF THE AMENDMENTS ADOPTED BY THE RID/ADR/ADN JOINT MEETING (BERNE, 25 – 28 MARCH 2008)

<u>Documents:</u> OTIF/RID/CE/2008/11 (Secretariat)

OTIF/RID/CE/2008/14 (Secretariat), paragraph 13

OTIF/RID/CE/2008/15 (Secretariat)

- 4. The Secretariat explained that document OTIF/RID/CE/2008/11 was the equivalent of document INF.15 for the 84th session of WP.15 and that it contained all the texts that had been adopted by the Joint Meeting (Berne, 25 28 March 2008). WP.15 had adopted informal document INF.15 with an amendment to the date of the legally binding application of standard EN 14025:2008 and with the deletion of the reference to standard EN 13094:2008, which still had to be approved by the Joint Meeting.
- 5. Document OTIF/RID/CE/2008/11 was adopted with the explanation on the status of the standards in document OTIF/RID/CE/2008/15 (see Annex 1).

ITEM 5: OTHER PROPOSALS

Corrections to the draft notification texts

<u>Documents:</u> OTIF/RID/CE/2008/9 (Secretariat)

OTIF/RID/CE/2008/14 (Secretariat), paragraph 8

6. The RID Committee of Experts adopted the Secretariat's document OTIF/RID/CE/2008/9, which contained a list of corrections to the draft notification texts that came to light when preparing the 2009 edition of RID. An additional amendment to Table 2 of packing instruction P 200 (UN number 2189) was also adopted (see Annex 1). A similar document was also submitted to WP.15 as informal document INF.9.

New edition of UIC leaflet 471-3 O

Document: OTIF/RID/CE/2008/2 (UIC)

7. UIC's document OTIF/RID/CE/2008/2 setting out minor amendments to section 5 of UIC leaf-let 471-3 O and proposing a modification to the reference to the latest edition of this UIC leaf-let in 1.4.2.2.1 was adopted (see Annex 1).

Training certificates with limited validity for dangerous goods safety advisers

<u>Documents:</u> OTIF/RID/CE/2008/6 (Switzerland)

OTIF/RID/CE/2008/14 (Secretariat), paragraphs 14, 16 and 17

8. The RID Committee of Experts adopted Switzerland's proposal to include the new UN number 3475 in the fifth indent of 1.8.3.13 and hence to extend the scope of application of training certificates with limited validity for dangerous goods safety advisers (see also informal document INF.6 for the 84th session of WP.15). Extending the certificate to cover aviation fuel (assigned to UN Nos. 1268 and 1863), which WP.15 adopted on the basis of an IRU proposal (see informal document INF.13 for the 84th session of WP.15), was also adopted, together with a transitional provision for training certificates issued before 1 January 2009 (see Annex 1).

Clarification in the transitional provision in 1.6.4.13

<u>Documents:</u> OTIF/RID/CE/2008/13 (Secretariat)

OTIF/RID/CE/2008/14 (Secretariat), paragraph 11

9. The Secretariat's proposal to include a point of clarification in 1.6.4.13 contained in the draft notification texts concerning the date of application of the provision of 6.8.2.1.7 (see also informal document INF.25 for the 84th session of WP.15) was adopted, together with a suitable new transitional provision for tank-wagons (see Annex 1).

Security provisions for explosive substances and articles containing explosives of division 1.4

<u>Documents:</u> OTIF/RID/CE/2008/8 (United Kingdom)

OTIF/RID/CE/2008/14 (Secretariat), paragraph 48

- 10. The RID Committee of Experts adopted the United Kingdom's proposal to apply in 1.10.4 the security provisions of Chapter 1.10 to certain UN numbers of Class 1, division 1.4, even if they come under the exemption of 1.1.3.6.3, as WP.15 had adopted a similar proposal (informal document INF.14 for the 84th session of WP.15) (see Annex 1).
- 11. The Chairman pointed out that although a rule had been agreed for explosive substances of division 1.4, other more dangerous explosive substances which came under transport categories 1 and 2, and which could therefore be carried in considerable quantities, were still not taken into account at all. The representative of the United Kingdom was asked to find a coherent solution in the context of the Joint Meeting.

Provisions for radioactive material of Class 7

<u>Documents:</u> OTIF/RID/CE/2008/12 (Germany)

OTIF/RID/CE/2008/14 (Secretariat), paragraph 66 and 67

12. The representative of Germany withdrew his document OTIF/RID/CE/2008/12, which set out proposals for amendments to the draft notification texts concerning Class 7 based on a comparison with the 2009 edition of TS-R-1. As WP.15 had decided that the amendments proposed (see also informal document INF.32 for the 84th session of WP.15) would have to be

submitted to the UN Sub-Committee of Experts first, it would not be wise to have a separate discussion within the RID Committee of Experts.

Editorial alignment of 2.2.9.1.10 with the text of the second revised edition of GHS

<u>Documents:</u> OTIF/RID/CE/2008/10 (Secretariat)

OTIF/RID/CE/2008/14 (Secretariat), paragraph 9

- 13. The RID Committee of Experts adopted the Secretariat's proposal OTIF/RID/CE/2008/10 to eliminate editorial differences between 2.2.9.1.10 of the draft notification texts and the second revised edition of the Globally Harmonised System for the Classification and Labelling of Chemicals (see also informal document INF.10 for the 84th session of WP.15) (see Annex 1).
- 14. While the Chairman welcomed the fact that this decision would bring about identical provisions, at least for Europe, as the European GHS law would also take over the text of the second revised edition of the GHS, the representative of the Netherlands regretted that the usual procedure where the UN Sub-Committee of Experts on the Transport of Dangerous Goods (TDG) took a decision beforehand had not been followed in this case.
- 15. The RID Committee of Experts was aware that there are differences between the English and French editions of the text that would have to be cleared up in future. For the German text of RID, the translation proposed in document OTIF/RID/CE/2008/10 was adopted.

Special provision 188

<u>Documents:</u> OTIF/RID/CE/2008/7 (Secretariat)

OTIF/RID/CE/2008/14 (Secretariat), paragraph 8

16. The RID Committee of Experts adopted the UN Sub-Committee of Experts' request set out in the Secretariat's document OTIF/RID/CE/2008/7, according to which the Sub-Committee wished to include a transitional provision in the draft notification texts in paragraph (b) of special provision 188 concerning the affixing of the Watt-hour marking (see also informal document INF.7 for the 84th session of WP.15) (see Annex 1).

Orange-coloured plates on tank-wagons carrying various dangerous goods

Document: OTIF/RID/CE/2008/4 (Belgium)

17. The RID Committee of Experts adopted without discussion Belgium's proposal to withdraw the amendment to RID 5.3.2.1.2, which was erroneously adopted by the Joint Meeting, from the draft notification texts (see Annex 1).

Attaching the instructions in writing in piggyback transport

<u>Document:</u> OTIF/RID/CE/2008/1 (Secretariat)

- 18. The RID Committee of Experts adopted the Secretariat's proposal to dispense with the instructions in writing as an attachment to the transport document, following WP.15's adoption of a new concept for instructions in writing, which in future only prescribes a standard model for all dangerous goods (see Annex 1).
- 19. The representative of UIC welcomed this decision, as attachments to the transport document were a major obstacle in the CIT/UIC "electronic consignment note" project. He said he would provide information on this project at the next meeting.

20. The Chairman suggested that the new concept of the instructions in writing should be introduced into RID in order to provide the locomotive driver with a standard set of instructions and thus to replace national rules. Germany would submit a proposal on this.

Re-insertion of a footnote in 6.2.3.6.2

Documents: OTIF/RID/CE/2008/5 (Secretariat)

OTIF/RID/CE/2008/14 (Secretariat), paragraph 8

- 21. The meeting adopted the Secretariat's proposal in document OTIF/RID/CE/2008/5 (see also informal document INF.5 for the 84th session of WP.15) to include a footnote from the current edition of RID in 6.2.3.6.2 of the draft notification texts as proposed by Switzerland at the Joint Meeting in March (see Annex 1). In connection with this, the RID Committee of Experts also approved the deletion of the text of 6.2.3.6.2 in the draft notification texts, because following an earlier decision of the Joint Meeting on the competent bodies for the conformity assessment and periodic inspection in 6.2.3.6.1, this text had become superfluous (see informal document INF.28 for the 84th session of WP.15).
- 22. In connection with this, the Secretariat pointed out that there was a difference between RID and ADR in the current text of this footnote. While RID also recognises the competent authorities of ADR Contracting Parties that are not a Member State of OTIF, ADR only takes account of the competent authorities of ADR Contracting Parties. WP.15 would be asked to align ADR with the wider-ranging wording of RID at a later stage.

Periodic inspection of gas tank-wagons

<u>Document:</u> OTIF/RID/CE/2008/3 (Secretariat)

- 23. The RID Committee of Experts adopted the Secretariat's proposal to align the deadlines for the periodic inspection of gas tank-wagons in the new 6.8.3.4.6 in the draft notification texts with the 2007 edition of RID, as none of the original documents contained any justification for shortening the deadlines (see Annex 1).
- 24. In this context, the representative of Switzerland pointed out that UN No. 1067 dinitrogen tetroxide (nitrogen dioxide) and UN 1076 phosgene should be deleted from the list of substances in 6.8.3.4.6 (a), as according to special provision TU 17, this gas may not be carried in tanks. This editorial amendment would also be taken into account after consultation with the UNECE Secretariat (see Annex 1).

Marking the tank-wagon with the date of the next inspection

Document: OTIF/RID/CE/GT/2008/2 (Belgium)

Informal document: INF.2 (Secretariat)

25. The RID Committee of Experts adopted Belgium's proposal OTIF/RID/CE/GT/2008/2, as amended by informal document INF.2, which had been checked in advance by the working group on tank and vehicle technology (Berne, 14 and 15 May 2008). The proposal was to add an indication to the date of the next inspection on whether the date may be exceeded by three months. This provision will enter into force on 1 January 2009 (see Annex 1).

Other amendments adopted by the 84th session of WP.15

<u>Document:</u> OTIF/RID/CE/2008/14 (Secretariat), paragraph 64

26. The RID Committee of Experts also adopted the amendment adopted by WP.15 on the basis of Sweden's informal document INF.31 concerning 1.6.1.13 contained in the draft notification texts (see Annex 1).

ITEM 6: EXCHANGE OF EXPERIENCES FOR EXPERTS

- 27. The discussion on the outcome of the exchange of experiences for experts (Berne, 13 May 2008) was postponed to the next session of the RID Committee of Experts.
- 28. The Chairman said that he wished more experts to attend. He requested the Member States to disseminate the results of the exchange of experiences at national level.
- 29. The representative of the United Kingdom pointed out that some of the documents submitted to the exchange of experiences did not come under its field of responsibility and that this should be taken into account better in future.

ITEM 7: CO-OPERATION WITH THE EUROPEAN UNION'S INTEROPERABILITY COM-MITTEE

- 30. The Chairman explained that in his capacity as Chairman of the RID Committee of Experts, he had taken part in the last meeting of the European Commission's Interoperability Committee and had given a presentation on the law governing the carriage of dangerous goods and its correlation to other fields of law. He was certain that there would be better co-operation in future. However, he said he would like the Interoperability Committee also to check whether its work was of relevance to the dangerous goods area and forward relevant information to the RID Committee of Experts.
- 31. The representative of the European Commission confirmed that the co-operation outlined by the Chairman would work in future.

ITEM 8: APPROVAL OF THE ADOPTED TEXTS AND TRANSITIONAL PROVISIONS, AND IMPLEMENTATION

32. In a final vote, the amendments adopted under agenda items 4 and 5 were unanimously approved for a date of entry into force of 1 January 2009 with a transitional period up to 30 June 2009.
