1.1.3.6.3 In the table, for transport category 0, Class 6.1, add ", 2312" before "and 3294" and insert a new row to read as follows:

"Class 5.1: UN No. 2426".

1.7.1.1 Replace the last two sentences of the new text published in Corrigendum 1 with the following:

"These standards are based on the IAEA Regulations for the Safe Transport of Radioactive Material, 1996 edition (as amended 2003), Safety Standards Series No. TS-R-1, IAEA, Vienna (2004). Explanatory material can be found in the "Advisory Material for the IAEA Regulations for the Safe Transport of Radioactive Material", Safety Standards Series No. TS-G-1.1 (ST-2) IAEA, Vienna (2002).".

1.10.5 In the table, for Class 7, replace "Type B or Type C packages" with:

"Type B(U), Type B(M) or Type C packages".
