#### **Note by the Secretariat**

---

The RID/ADR/ADN Joint Meeting (Berne, 13 to 17 March 2017) decided some corrections to the 2017 editions of RID, ADR and ADN (see report ECE/TRANS/WP.15/AC.1/146, paragraph 60 and Annex III), which the 102<sup>nd</sup> session of WP.15 has now approved for ADR (see OTIF/RID/CE/GTP/2017/5, paragraphs 18, 19, 47 and 48).

On 3 July 2017, under reference C.N.345.2017.TREATIES-XI.B.14, the Secretary-General of the United Nations, acting in his capacity as depositary, notified the ADR Contracting Parties of these amendments. Within three months from the date of the notification, i.e. by 3 October 2017, the ADR Contracting Parties may lodge objections to these corrections. The notification also proposes that the corrections should enter into force after a further three months, i.e. on 3 January 2018.

The Secretariat suggests that the corrections to RID listed below should also enter into force on 3 January 2018.
