TO THE MEMBER STATES AND ASSOCIATED MEMBERS OF OTIF AND TO REGIONAL ORGANISATIONS WHICH HAVE ACCEDED TO COTIF

17<sup>th</sup> Session of the RID Committee of Experts' standing working group (Berne, 22 May 2024)

- 1. At the 16<sup>th</sup> session of the RID Committee of Experts' standing working group (London, 20 to 23 November 2023), it was agreed to hold the 17<sup>th</sup> session on 22 and 23 May 2024 (see report OTIF/RID/CE/GTP/2023-A, paragraph 59). Directly after this meeting, the 58<sup>th</sup> session of the RID Committee of Experts was to be held on 23 May 2024. At this session, all the amendments that are due to enter into force on 1 January 2025 should be formally adopted.
- 2. In view of the fact that few documents other than those for the 2025 revision of RID have been announced, it has been agreed with the Chair, Ms Caroline Bailleux, and the Vice-Chair, Mr Othmar Krammer, to shorten the 17<sup>th</sup> session of the standing working group to one day and to hold the 58<sup>th</sup> session of the RID Committee of Experts on the morning of 23 May 2024.

## TIME OF THE MEETING

- 3. The 17<sup>th</sup> session of the RID Committee of Experts' standing working group will be held on Wednesday, 22 May 2024. The meeting will start at 10:00 CEST and will end at 17:30 CEST.
- 4. The 58<sup>th</sup> session of the RID Committee of Experts will take place on Thursday, 23 May 2024 directly after the 17<sup>th</sup> session of the standing working group. The invitation to the RID Committee of Experts will be sent separately.
- 5. The 17<sup>th</sup> session of the standing working group and the 58<sup>th</sup> session of the RID Committee of Experts will be organised as meetings with personal attendance only.
