Invitation and provisional agenda

### 11 and 12 June 2024 as a hybrid meeting.

Participants will have the option of being physically present or may participate remotely. For those who wish to attend in person, the session will take place at the

### Universal Postal Union Weltpoststrasse 4 3015 Berne, Switzerland.

The session will begin on Tuesday, **11 June 2024 at 10:00 (Central European Summer Time)** and will finish no later than Wednesday, **12 June 2024 at 13:00 (Central European Summer Time)**. The session will be followed by the  $52^{nd}$  session of the working group Technology (WG TECH), for which a separate invitation will be sent in due course.

### Languages

The working languages will be English, German and French with simultaneous interpretation.

#### Agenda

The provisional agenda and provisional timetable are attached to this circular as Annex A and Annex B.

The agenda will be determined in accordance with Article 8 of the Committee's rules of procedure. If the Secretary General receives requests to place other business on the agenda not less than 18 weeks prior to the meeting, i.e. by **5 February 2024**, the Secretary General will send addressees an adapted version of the provisional agenda. Requests received after that date will be presented at the session.

#### Working documents

Documents relating to the meeting will be made available in accordance with Article 9 of the Committee's rules of procedure on OTIF's website (<u>www.otif.org</u>) under:

The Secretary General will send digital copies by e-mail at the request of any member of the Committee. Paper copies will be sent only at the request of members who cannot receive or obtain documents by electronic means.

Working documents prepared by the Secretary General which contain proposals for binding provisions in the meaning of Article 20 § 1 of COTIF or Article 33 § 6 of COTIF will be made available not less than 16 weeks prior to the meeting, i.e. by **19 February 2024**.

Other working documents prepared by the Secretary General will be made available 8 weeks prior to the meeting, i.e. by **15 April 2024**.

Working documents prepared by a member of the Committee or by an observer should be submitted in accordance with the deadlines laid down in Article 11 of the rules of procedure.

## Composition, voting rights and quorum

The Committee of Technical Experts is composed of all Member States of OTIF. However, when deliberating or taking decisions within the meaning of Article 20 § 1 of COTIF, only those Member States of OTIF which have not made a declaration concerning the APTU UR and the ATMF UR (Appendices F and G to the Convention) in accordance with the first sentence of Article 42 § 1 of COTIF will have the right to vote. These Member States are referred to as the Contracting States. The Member States that are not Contracting States will be able to participate in the discussions on these agenda items but cannot vote.

A list of Member States and their application of the APTU UR and ATMF UR is attached as Annex E.

There is a quorum in the Committee of Technical Experts when one-half of the Contracting States are represented. As no formal decisions can be taken if there is no quorum, it is very important that the Contracting States are represented at the session. According to Article 16 § 3 of COTIF, Contracting States may delegate powers (including the right to vote) to another Contracting State. However, no Contracting State may represent more than two other Contracting States. A model proxy is attached as Annex F.

### **Regional economic integration organisation – European Union**

In accordance with Article 38 § 2 and 3 of COTIF, a regional organisation may exercise the rights enjoyed by its members by virtue of the Convention to the extent that they cover matters for which it is competent. For the purpose of exercising the right to vote at the Committee of Technical Experts, the regional organisation shall enjoy the number of votes equal to those of its members which are also Contracting States.

In accordance with Article 6(4) of the agreement between OTIF and the European Union (EU) on the accession of the EU to COTIF<sup>1</sup>, the European Union should inform the Secretary General of those agenda items in respect of which it will exercise the voting rights. The Secretary General will share this information with the members of the Committee and observers as soon as it is received.

## Observers

Firstly, Associate Members of the Organisation may participate in the work of the Committee of Technical Experts as observers in accordance with Article 39 § 2 of COTIF.

Secondly, at its 16<sup>th</sup> session, the Committee of Technical Experts established a list of registered stakeholders and a list of intergovernmental organisations that are permanently invited to its sessions. This list is set out in Annex C.

Thirdly, subject to the conditions of Article 16 § 5 of the Convention, the Secretary General may invite states which are not members of the Organisation and relevant international organisations and associations as observers. The Secretary General intends to invite the states indicated in Annex C to this session of the Committee. Member States are asked to send any objections they may have concerning these invitations to the Secretariat by no later than **2** April 2024. The Secretary General will assume the tacit agreement of the Member States that do not object before this date.

#### PRACTICAL INFORMATION

#### Registration

The registration form should be filled out and returned to the Secretariat by 13 May 2024 at the latest.

Contracting States which are not going to send a delegate are kindly requested to inform the Secretariat, also by **13 May 2024** at the latest, of the Contracting State to which it intends to delegate powers. A model proxy is attached as Annex F.

The Secretariat would be grateful if Contracting States that do not intend to be represented at all could inform the Secretariat accordingly.

#### Visa

Delegates must be designated by the competent authorities of their Government and must inform the Secretariat of OTIF accordingly before requesting an entry visa for Switzerland, with the necessary supporting documents, from the nearest Embassy or Swiss Consulate.

Delegates who require help from the Secretariat of OTIF to obtain a visa are requested to do so at least **six weeks** before the date of the meeting, i.e. by **30 April 2024** at the latest.
