#### Annex 3

# How to get from Bern railway station to the meeting venue

The meeting will take place on the 4<sup>th</sup> floor of the building where the OTIF Secretariat's temporary offices are located. The building is walking distance from train/tram/bus station Gümligen (Gümligen Bahnhof).

OTIF temporary office, Worbstrasse 201, 3073 Gümligen, Switzerland

From Bern station (Bern Bahnhof) you can reach Gümligen directly by taking:

- Tram line 6 in the direction of Worb. This tram takes 17 minutes to reach Gümligen (9<sup>th</sup> stop).
   It also stops in the centre of Bern (Bern Bärenplatz, Bern Zytglogge, etc.), or
- Train S1 in the direction of Thun. This train takes 10 minutes to reach Gümligen (3<sup>rd</sup> stop).
- Train S2 in the direction of Langnau i.E. (Langnau im Emmental). This trains takes 10 minutes to reach Gümligen (3<sup>rd</sup> stop).
