The documents have been placed on the OTIF website under "Technology" > "Regulations in force" > "UTPs and others".

According to APTU Article 12 § 1 analogous notified national technical requirements concerning freight wagons and noise may not remain in force after the entry into force of the respective UTP.

According to APTU Article 12 § 2 the Contracting States shall inform the Secretary General - with justification - of those national technical requirements which it requires to be complied with in order to ensure technical compatibility between the freight wagons and its network. This includes national rules applicable to "open points" in the UTP WAG (the UTP NOI does not contain open points) and applicable to the specific cases in UTP NOI and UTP WAG.

Member States which have not yet ratified COTIF 1999 or which have made a declaration in accordance with Article 42 of the Convention not to apply Appendix F APTU (for UTPs) and/or Appendix G ATMF (for Annexes to ATMF) to COTIF 1999 will not be affected by the entry into force of these regulations until they ratify COTIF 1999 or until their declarations are withdrawn.

By the date on which a Member State becomes a Contracting State to COTIF 1999 (i.e. the date on which its ratification of COTIF 1999 or its revocation of its declaration in accordance with Article 42 of the Convention enters into force), it must comply with the above-mentioned regulations. All Member States have always been informed of regulations that have been proposed, adopted and notified, and of the entry into force of these regulations.

The consequence of not complying with the deadlines for implementation is that the Contracting State in question cannot legally issue COTIF technical certificates for subsystems in international traffic to which the non-implemented regulations apply. In addition, other Member States are not obliged to recognise technical certificates issued by States that have not implemented the regulations.
