# Subject: Draft list of corrections to the notification texts OTIF/RID/NOT/2017 of 30 June 2016 and to the 2017 edition of RID

#### Information from the Secretariat

- 1. None of the OTIF Member States lodged any objections against the notification texts OTIF/RID/NOT/2017 of 30 June 2016. The Member States will be sent the relevant letter at the end of November.
- Together with this letter, the Member States will also be sent a list of correction setting out all the corrections and additions to be made to the notification texts. In addition, the Member States will receive a list of corrections to the printed 2017 edition of RID containing such mistakes which could not be taken into account when preparing the consolidated version.
